Thank you for your Freedom of Information request received on 10<sup>th</sup> November 2017. You asked:

"Please will you provide a copy of all of the training materials used to train Work Coaches including trainer notes, presentations, handouts, exercises/activities, user guides, trainee workbooks, guidance, user manuals etc.

In addition, please provide details of the assessment process for role and the process for appraising staff up and running in the post.

Also, it will be helpful if you can advise if the training is delivered by DWP employees or another training provider and also provide the materials in a zip folder."

## **DWP Response:**

The Department's learning materials are not available externally, so extracting and converting or printing them is time intensive. We are unable to supply the full Work Coach training materials because of the number of products involved. For example, there are 56 separate products on the technical learning journey for a new Work Coach, as well as additional modules on support for different claimant groups, foundation learning modules on core skills and the responsibilities of a Civil Servant, and additional technical learning specifically around working in Universal Credit. Each product can take 1-2 hours to extract, due to the format in which they are hosted and the number of pages in each product, especially where they are provided as elearning. This means that providing all the Work Coach learning products would exceed the £600 cost limit specified in the regulations for central Government. Therefore under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request.

Should you want to focus your request on a specific subject area in which Work Coaches receive training, this may allow us to provide the required information, subject to the parameters of the Freedom of Information Act.
