Dear D Moore,

Thank you for your Internal Review request received on 21 December 2016. An internal review has been carried out by someone of a senior grade to the person who dealt with your original request. I am now in a position to respond to you. In your review request you said:

*"I am writing to request an internal review of Department for Work and Pensions's handling of my FOI request 'Workfare partner the Jesus Army Centre'.*

*I do not believe that dealing with part 3 of my request would exceed the cost limit as you claim.*

*"3. Please provide the names of all workfare schemes that the providers provided to the Jesus Army Centre. I do not need this information for each individual provider. If, for example, all 70 providers provided scheme X, I do not need to know that each provider provided scheme X, only that scheme X was provided. "*

*I also wish you to provide the information I requested in part 1 of my request in respect of the 70 providers connected to the Jesus Army Centre, not every provider nationwide. When I input 'Jesus Army Centre' into the search box to which you provided a link I got a message telling me that 1,000 records were available.*

In response to your request, I can confirm that the handling of your original request and response has now been appropriately reviewed by someone unconnected with the handling of your original request.

As a result of this review I can advise that I find the original decision to be correct. Your request for review is therefore not upheld. The reasoning behind this decision is as follows:

As explained in our reply of 25 November 2016, we estimate that the cost of complying with your request would exceed the appropriate limit for central Government, set by regulations at £600.

We did not provide a link to information in our reply of 25 November. However, in the interests of customer service, I can tell you that Section 21 of the Freedom of Information Act allows us to direct you to information which is already reasonably accessible to you. The Act does not require us to interpret such information.
