Your request for information has now been considered and the information requested is detailed below in respect of the LBR Children's Services.

Please find a list of training commissioned during 2011 – 2012 and 2012 – 2013 under the variety of Programmes available to our staff. The lists include the training provider and the cost. These lists exclude training accessible via the LSCB Training Programme, the Corporate Learning and Development Programme and elearning via Learning Zone, provided via Corporate contract by Learning Pool.

In addition LBR Children's Services is in partnership with a number of organisations which support learning and development. These are included below, with costs:

- Community Care Inform licences £9000 in 2012 and £9000 in 2013;
- Making Research Count (MRC) Membership £5000 in 2012 and £5000 in 2013; and
- Research in Practice membership £15,000 in 2011 and £15,000 in 2011

The training budget 2011 – 2012 was £162,674 and in 2012 – 2013 £201,854. These figures exclude grants. The budget for 2013 – 2014 will be similar, with the addition of grants, not all of which have been fully confirmed.
