This contract is to appoint a contractor to deliver the operational elements of the Commercial Energy Certificate Register and Associated Consolidated Services across England and Wales.

The successful contractor will provide an on-line, web enabled I.T. infrastructure that will support the implementation of the Energy Performance of Buildings Regulations in England and Wales in early 2008. The Department requires a contractor to deliver:

A system that holds

Accreditation information in respect of Energy Assessors;
Energy Assessments associated with non-domestic and public buildings;
Financial information in respect of subscription and lodgement fees

A system that supports:

The registration of Energy Assessors
The lodgement and maintenance of current and historical Energy Performance Certificates and Display Energy Certificates and data required to calculate ratings in the certificates;
The retrieval of Energy Certificates by interested parties e.g. potential purchasers or tenants entering the certificate number;
The retrieval of Energy Certificates or their associated data by authorised users;
The collection and processing of financial charges in respect of subscription and lodgement fees;
The provision of financial information to authorised users;

The provision of monitoring reports to the Accreditation scheme organisations;

A security model that protects the integrity of the data and limits access to valid users;

A software testing facility to allow providers of Commercial Energy Assessment software to test and apply for software accreditation (the scope and responsibilities of the accreditation scheme will be defined during requirements definition stage).

A communications network that provides access to the database and the system facilities incorporating:

A secure network either within or outside of the GSI, that meets current government standards and guidelines for security;

A private network linking key industry users to the system

A system interface linking the system with:

the Accreditation scheme organisations

other relevant parties involved in the energy assessment process

An environment that allows controlled access to the database on a 24/7 basis with appropriate disaster recovery and business continuity facilities.

The successful contractor will administer all aspects of the delivery of the Commercial Energy Certificate Register and Associated Consolidation Services. This would include promotion and marketing of the register; producing and providing information, materials and direct advice about the register; developing and managing an effective and efficient applications system.
